1. VARIANCE #VAR-26-05: BOHN

Public notice is hereby given to all persons in the Town of Rusk, Burnett County, Wisconsin, that Craig and Pamela Bohn have made an application relative to a proposal to vary the terms of the Burnett County Land Use and Shoreland Protection Code of Ordinances as follows: To leave a patio that was constructed without a land use permit which does not meet the required setback to the Ordinary High Water Mark (OHWM) of Rice Lake and to leave an expansion to a non-conforming cabin/dwelling that was constructed without a land use permit which exceeds 25 percent of the building envelope; at 2069 County Rd G, in the RR-1 zoning district, Lot 1 CSM Vol. 19 Pg. 140 and a parcel described in document # 494941, in Government Lot 5, Section 10, T39N, R14W.
